Zero Carbon Communities

The seventh round of South Cambridgeshire's Zero Carbon Communities (ZCC) grants launch today (May 5) offering a share of £125,000 to successful applicants. The grant scheme supports projects which help reduce carbon emissions or 'lock up' carbon, as well as projects that foster community engagement on climate change.

Closing date for applications is 5pm on Tuesday 1 July 2025. Applications can be made using the online form on the <u>grant webpage</u>. Updated grant information and application guidance documents have been made available to help applicants.

NHS Healthy Start Campaign

South Cambridgeshire has seen the biggest increase in NHS Healthy Start claims in the country, following a targeted campaign by the District Council encouraging eligible parents to sign up for free food and milk support. The three-week campaign is projected to have distributed nearly £60,000 of previously unclaimed funds.

The Healthy Start scheme is offered by the NHS to parents receiving certain benefits but were estimated to go unclaimed by more than a third (38%) of eligible parents in South Cambridgeshire which is why the District Council campaign was launched.

The easiest way to apply for the Healthy Start scheme is <u>online</u>. If residents are unable to apply online, they can call the Healthy Start helpline on **0300 330 7010** and a member of staff will help complete an application.

Cambs County Council

May 1st Elections

Cambridgeshire County Council's largest political group are the Liberal Democrats following yesterday's elections. The final results, declared at counts across the county (Friday, 2 May), saw the Liberal Democrats win 31 seats. The Conservatives won 10 seats, Reform UK won 10, Labour won 5, the Green Party won 3, and 2 seats were won by independent candidates.

The council will agree key political roles – including the Leader of the Council and all key committee appointments – at its Annual General Meeting of the local authority which will be held on Tuesday, 20 May at New Shire Hall, Alconbury Weald.

Primary School Places

A total of 94.5 per cent of Cambridgeshire children will be going to their first preference primary school this September, above the national proportion of 93.2 per cent from 2024.

This is marginally down from the 95.9 per cent offered their preferred choice in Cambridgeshire last year. The proportion offered a place at their first, second or third choice school has also slightly fallen – from 99.1 per cent last year to 98.9 per cent this year.

Just over 1 per cent of pupils (76 children in total) have been allocated places at other schools, outside of their expressed preferences, the second lowest number in the last four years.

Updates

- a. Wellcome Trust Campus Development. The roadworks have been completed to date, although there may be more later. There is a new person in Charge of the development who seems to be very amenable to co-operate with the village, the New Road junction has been test driven and it was agreed that there seems to be a fault with the design, it is hoped that it will be corrected soon.
- b. Village Hall extension. The plans have now been received from the Moses's, they have been shown to the Village Hall Committee and some of the immediate neighbours, there are some updates to be made and they will then be available for everyone to look at and comment on. It is hoped that a presentation will be arranged at the Village Hall later. The cost with VAT is much higher than expected, Clerk will see if we can reclaim VAT and AB will also investigate this as it will make a big difference.
 - A message has been received to see if there was anything that the village needed- ie the Mill. This would be passed on to Cambridge Past Present and Future as there is an urgent appeal for money to repair the brick bridge which will cost approx. £20,000.
- c. Wetlands Committee. Walks continue regularly, dates can be found on the website
- d. Playground report following inspection of playground, it is still saying that the Carousel is not t the correct height despite having been installed by the company that supplied it. The trees over the climber need cutting back, Sarah to see about getting this done. The seesaw has now been fixed.
- e. Highways nothing new to report.
- f. Bus service in village- nothing to report.
- g. Quiet Lanes. Some response have been received following the request in the Hinxton News for people to help. There were not many responses but thanks given to those who had helped. No definite conclusion can be drawn, mainly due to minimal data and seasonal variations. More people walking at lunchtime- probably from local businesses and the Campus. It was decided to continue the survey, contact local landowners and raise awareness of the intent to apply for Quiet Lane status.

- h. Buying a speed restriction unit- deferred to the June meeting.
- i. River/weir . No meeting has been arranged as yet, this needs to be between all parties involved.
- j. Dog poo bins. 2 bins to be ordered and installed, Clerk to arrange this.
- k. War Memorial has now been cleaned and the lettering reinstated. The railings have been straightened as much as possible, but they really need to be completely removed which means chipping them out of the concrete. Clerk to get a quote on this being done and raising the height of the corner posts and railings.
- I. Village Litter pick. This went very well with a good number of people attending. It was heartening that not much litter was collected, in part due to the volunteers who regularly pick up litter around the village and along the A1301. Thanks were expressed to those attending, the organisers and to Alex at the Red Lion for providing refreshments afterwards.

2505/09 New items for discussion

Drainage problems in North End/High St. This has been an ongoing problem for several years, despite the drain being cleared, the water has nowhere to go and when there is heavy rain, the ditch overflows onto the property next to the ditch. This is a complicated issue as several different parties involved, it was proposed by CE, seconded by HT and all in agreement that Clerk will write a letter of support for the residents involved, with hopes that this will soon be sorted out.
